RE: Covid protocol for attending 2021 Grand Lodge Events

Greetings, in the matchless name of Jesus Christ, our Savior:

This letter is to inform everyone of the Covid protocol procedures that have been put in place to help ensure everyone's safety during our 153<sup>rd</sup> Annual Session.

On Monday, there will be staff prepared to receive your Covid-19 Self-Assessment Questionnaire and Covid-19 Liability Waiver (provided on site). At that time you will need to provide proof of your vaccination card or if you are not vaccinated, proof of your NEGATIVE Covid test results within the (3) days prior to coming to Grand Lodge Events. After that you will have your temperature taken and recorded and you will receive a white wrist band. Without that wristband, you will not be allowed to enter any event we have on Monday to include the banquet.

On Tuesday morning you will need to bring your white wristband and have your temperature taken in order to receive your PURPLE wristband to be allowed to enter into the room for our session. Without the purple wristband on Tuesday you will not be allowed to enter.

Please know that this procedure is for your safety so please follow these directions and we look forward to a memorable and enjoyable time for our 153<sup>rd</sup> Annual Session.
